PRIMAL™ 928AP Emulsion is a high solids, acrylic copolymer emulsion that facilitates the formulation of clear sealants with excellent clarity and pigmented sealants with good performance. PRIMAL 928AP Emulsion is APEO-free⁽¹⁾ and manufactured without added formaldehyde or formaldehyde generators⁽²⁾. Both clear and pigmented sealants formulated with PRIMAL 928AP Emulsion offer excellent adhesion to a wide variety of substrates.

- Facilitates the formulation of un-pigmented sealants with excellent clarity.
- Very high solids polymer that assists to minimize shrinkage.
- Good water resistance, blush resistance and dirt pick-up resistance.
- APEO-free⁽¹⁾ and no added formaldehyde or formaldehyde generators⁽²⁾.

- Facilitates the formulation of sealants with excellent wet and dry adhesion to a range of substrates including glass, aluminium and ceramic tiles.
